Upper Los Angeles River Watershed Area Steering Committee (WASC)



1. Welcome and Introductions

Mr. CJ Caluag provided an overview of the WebEx interface and provided instructions for a member of the public to provide a comment during the Public Comment Period. He facilitated roll call voting for attendance and guorum was established.

Mr. David Nahai, the Chair of the Upper Los Angeles River WASC, called the meeting to order.

2. Approval of Meeting Minutes from April 30, 2020

The District provided a copy of the meeting minutes from the previous meeting. Mr. Nahai asked the WASC members for comments or revisions, there were none. Mr. Gary Hildebrand motioned to approve the minutes, Mr. Yazdan Emrani seconded the motion. The WASC did a roll call vote to approve the meeting minutes from April 30, 2020 (unanimous).

3. Committee Member and District Updates

Mr. Caluag gave updates on the Watershed Coordinator solicitation. The Request for Statement of Qualifications is anticipated to be posted on May 26. The WASC will conduct an interview and ranking process with each of the candidates around August. The process has not been finalized at this time. Then Board approval will be around September.

The Regional Oversight Committee (ROC) is scheduled to meet on May 20, June 18, and June 24. See website for meeting details. When the WASC votes on the Stormwater Investment Plan (SIP), District Staff will send a SIP submittal to the ROC and the Chairs and project applicants were advised to attend the meeting to answer questions.

4. Public Comment Period

Mr. Caluag called on public members that submitted Public Comment Cards to the Safe, Clean Water prior to the meeting. See attachment for the Public Comment Cards and letters.

Mr. Shahriar Eftekharzadeh (SEITec) expressed concern that the projects being considered are using inefficient infiltration systems and that costs can be reduced with more optimate infiltration systems.

Ms. Diana Mahmud (City of South Pasadena) recommends that the WASC does not fund projects that request 50 percent of the WASC's funds to consider funding Technical Resources Program and Scientific Studies that help smaller cities that cannot fund feasibility reports for Infrastructure Program projects.

Mr. Edgar Campos (T.R.U.S.T. South Los Angeles) expressed the region's great need of parks and open space and requests that the WASC considers projects that will be transformational to our community by promoting economic opportunity and connectivity to green spaces. See attached letter.

Mr. David Dolphin (City of Alhambra) noted that two of the Scientific Studies were approved for funding in the Rio Hondo WASC and that it would be advantageous for the ULAR WASC to move forward with those studies as well.

Mr. Eli Lipmen (South Los Angeles Transit Empowerment Zone) expressed support for a rail to river project application.

Mr. Sherilyn Correa (City of Los Angeles – Council District 9) expressed the City of Los Angeles' great need of parks and open space and expressed support for a project application.

Mr. Shona Calzada Ganguly (The Nature Conservancy and OurWaterLA) expressed the need for multibenefit projects, that promote equity, and green job creation.

District staff unmuted call-in users. No one spoke.

5. Discussion Items

a) Ex Parte Communications

The WASC did not have any ex parte communication disclosures.

b) Discussion of project rankings

Mr. Nahai gave an overview of the current funding request from all the projects and invited the WASC to discuss the project rankings and to discuss the percent allocation. District staff shared the SIP Planning Tool on the screen.

The WASC discussed how the funds are rolled over in the next year. District staff explained that the funds for the ULAR WASC will be rolled over to the next year and the interest accrued from the unused ULAR WASC funds may go to the District funding. District staff will confirm this.

The WASC noted that uncertainties with the pandemic could affect the ULAR WASC funds in the future years and they may want to approach a more conservative percent allocation funding. On the other hand, the WASC discussed the benefits of using the funds to stimulate the economy.

The anticipated revenue for the ULAR WASC this round is approximately \$38.6 million. 80 percent of \$38.6 million is approximately \$30.9 million and 75 percent is approximately \$28.9 million.

The WASC also noted to consider that the next call for projects is in July and Watershed Coordinators will be on board for the next call for projects and funding round.

c) Populate the Stormwater Investment Plan planning tool

Mr. Caluag shared the WASC's ranking results on the screen and explained how the "score" was calculated. See the results in the image below.

The WASC requested to redistribute the Lankershim Boulevard Local Area Urban Flow Management Network Project and Oro Vista Local Area Urban Flow Management Project funding over the five years instead of the current distribution over two years. The project applicant agreed. With all the projects toggled on, the SIP Planning Tool results for Fiscal Year (FY) 20-21, FY 21-22, FY 22-23, FY 23-24 and FY 24-25 funding was 79 percent, 70 percent, 33 percent, 17 percent, and 10 percent, respectively. The WASC expressed concern that their rankings would have been different had they known about the funding redistribution of the two projects. Although the rankings would have been different, there will still be a vote in which WASC members can change their preferences on projects.

The WASC requested to remove the two Scientific Studies (Coordinated Safe Clean Watershed Plans and Regional Scientific Study to Support Protection of Human Health through Targeted Reduction of Bacteriological Pollution) that did not get sufficient rankings from the WASC. In other words, they did not receive a "score". The SIP Planning Tool results for FY 20-21, FY 21-22, FY 22-23, FY 23-24 and FY 24-25 funding changed to 76 percent, 66 percent, 29 percent, 16 percent, and 10 percent, respectively.

A WASC member expressed concern for funding Franklin D. Roosevelt Park Regional Stormwater Capture Project because it is already fully funded and that there is no guarantee that the reimbursement funds will go towards projects that meet the Safe, Clean Water Program Goals. The project applicant said that the funds will go to new projects within the region to further meet water quality goals. The WASC noted that funding the project does not allow them to approve what the reimbursement funds will be used for. The WASC requested to see the funding scenario where the project is not funded. The SIP Planning Tool results for FY 20-21, FY 21-22, FY 22-23, FY 23-24 and FY 24-25 funding changed to 66 percent, 61 percent, 27 percent, 15 percent, and 9 percent, respectively.

Mr. TJ Moon responded with reasons to support the Franklin D. Roosevelt and reminded the WASC it would be a showcase project for SCW. Mr. TJ Moon motioned to approve the SIP including the project and excluding the two scientific studies mentioned above for the 76 percent allocation for FY 20-21. Mr. Gary Hildebrand seconded the motion. Mr. Nahai opened a discussion on the motion.

The WASC clarified that approving the SIP means approving funding for FY 20-21 and the remaining years are earmarked provided that they comply with the Fund Transfer Agreement. The WASC discussed how the SIP will be formulated in the future years. District staff noted that project applicants will provide quarterly reports to the WASC. At that point, the WASC can ensure that the funds are being used appropriately and reevaluate the funding distribution. If an approved project needs more funds in the future, they will have to resubmit an application for more funding.

The WASC expressed that there should be additional discussions on redistributing funding for other projects over the five years, such as the City of San Fernando Regional Park Infiltration Project.

Mr. Mike Antos reminded the WASC that as the WASC is preparing the next SIP, they can talk to the approved project proponents from this SIP to redistribute funds for the ensuing years.

The WASC requested to redistribute the Franklin D. Roosevelt Park Regional Stormwater Capture Project funds over two years instead of one year. The SIP Planning Tool results for FY 20-21, FY 21-22, FY 22-23, FY 23-24 and FY 24-25 funding changed to 71 percent, 67 percent, 29 percent, 16 percent, and 10 percent, respectively.

The WASC expressed concern for the 67 percent projection for year two (FY 21-22).

T.R.U.S.T. South LA is a community-based effort that works to stabilize the neighborhoods south of Downtown LA, where increased property values and rents have pushed out many long-term residents. Our mission is to serve as a steward for community-controlled land; to be a catalyst for values-driven, community-serving development; to build awareness and community leadership in issues of housing, transportation and recreation; and to create programs and initiatives that encourage community building and economic opportunity.

On behalf of TRUST South LA and South L.A residents across the 8th and 9th District, I am writing to share that our region in the City of Los Angeles is in great need of parks and open space. According to the Parks Needs Assessment conducted by the County of Los Angeles in 2016 the majority of the district is in high need of additional park, recreation, and open space investments. Considering that parks are a key infrastructure element in improving the quality of life of the community. Residents are eager to identify new park locations and opportunities to bring in the necessary infrastructure improvements the area deserves. As example of our efforts we have put forward \$2M dollars towards acquisition and revitalizing a property adjacent to the railway.

After decades post deindustrialization the Rail to Rail Active Transportation Corridor has sat blighted for decades after the Burlington Northern and Santa Fe (BNSF) Railway Company abandoned their rail line and Metro subsequently acquired the right of way in hopes of future redevelopment. The railway extends from the soon to be completed Crenshaw/LAX line to the A-line station at Slauson and Long Beach Avenue.

Our members strongly support the Active Transportation Rail to River Corridor Project - Segment A for consideration of Measure W Regional Program funding. We believe this project will be transformational to our community by promoting economic opportunity and connectivity to green spaces in addition to enhancing water quality.
