1. Welcome and Introductions

District staff conducted a roll call of committee members, and with a majority present, quorum was established. The meeting was called to order. The District discussed housekeeping items and the public comment process.

2. Approval of Meeting Minutes from November 4th, 2020

Ms. Lisa Ann Rapp asked if committee members have reviewed November 4, 2020 minutes and if there were any changes to be made. With no changes requested, Ms. Rapp requested a motion to approve minutes. Mr. Delfino Consunji motioned to approve minutes, with Ms. Kristen Ruffell seconding.

The Committee voted to approve the meeting minutes from November 4th, 2020 (14 Yes, unanimous).

3. Committee Member and District Updates

Ms. Melanie Morita (District) provided the District update noting: the Scoring Committee has begun scoring projects, all municipal transfer agreements have been sent out and the District has begun receiving annual plans, all regional transfer agreements are now out and the District has begun receiving scopes of work, and the ROC will discuss today partial funding guidance and interim guidance moving forward.

a) Watershed Coordinator Selection

i) Process Overview

During the interview process, District staff will read each interview question and have it presented on the screen. Each Watershed Coordinator (WC) will be allowed 20 minutes to answer all the questions. District staff will manage a timer and provide a time remaining reminder to the interviewees at the end of the interview and then 10 minutes will be allowed for follow up questions and answers. Committee members were sent the set of WC interview questions, note-taking sheet, the WC roles/responsibilities, and each WC's Statement of Qualifications (SOQs). It is important to write notes to remember critical information when voting at the next meeting, or should the Committee member present at today's meeting not be present at the following meeting (in this case, the meeting notes should be passed onto the alternate member). If any of the Committee members have a financial link to any of the WC interviewees, these Committee members must recuse and remove themselves from the WC selection process. For WC applicants that did not meet the scoring threshold, debriefing meetings have already been scheduled with LA County Public Works' Contracts Division.

Mr. Knapp asked if applicants can be the coordinator for more than one watershed area. The District responded the coordinator will have the first right of refusal, and if they do not pick this watershed area, the WASC will vote for another coordinator.

Mr. Negrete stated that he would have preferred an interview panel. The District stated that generally the interview process is done in closed sessions, but the ordinance allows the WASC to select and interview the WC proposers. Per Brown Act, a meeting that has a quorum is required to be a public meeting. Ms. Bloxom asked about the voting methods and the District shared a couple options that are being explored.
