### 1. Welcome and Introductions

Melissa You, new Chair of the Lower San Gabriel River WASC, welcomed Committee Members and called the meeting to order.

The District conducted a brief tutorial on WebEx and facilitated the roll call of Committee Members. All Committee Members made self-introductions and a quorum was established.

## 2. Approval of Meeting Minutes from August 10, 2021

The District provided meeting minutes from the previous meeting. Member Rojas made a motion to approve the meeting minutes. Member Juarez seconded. The WASC voted to approve the August 10, 2021 meeting minutes. (Approved, see Vote Tracker sheet).

## 3. Committee Member and District Updates

There were no Committee Member updates.



District Staff provided the District update, noting:

- The Regional Oversight Committee submitted the 2021 Stormwater Investment Plans to Board of Supervisors for approval. It will be up for adoption at the Board meeting on September 15.
- Round 3 Call for Projects deadline was July 31. The program received 41 Infrastructure Projects,
   8 Scientific Studies and 7 Technical Resources Program submittals.
- For LSGR, there are 7 Infrastructure Program, 5 Scientific Studies, 0 Technical Resources Program submittals. Three presentations for Scientific Studies are on today's agenda.
- The Scoring Committee has started reviewing Infrastructure Program projects and is reviewing 1
  project from LSGR, the Stormwater Treatment and Reuse System Hacienda Park. The other LSGR
  project are scheduled for review at the Scoring Committee on November 2.
- Regional Programs project applicants are required to submit quarterly and annual reports. Quarterly reports were due August 15 from current projects..
- Public Works executed all 12 Watershed Coordinator contracts and will proceed with their approved Stakeholder Outreach and Engagement Plan (SOEP).
- As part of the Municipal Program, each municipality must report Fiscal Year 21-22 Annual Plan by April 1 to receive annual payment, which will be dispersed October 2021.

## 4. Watershed Coordinator Updates

Watershed Coordinator Anderson provided updates on Watershed Coordinator Active Tasks with a presentation.

- Potential interested parties were identified for the upcoming stakeholder meeting.
- Four outreach meetings are expected by the watershed coordinator. Communication methods, including outreach materials and social media, were described.
- A summary video of the educational event and concert held in Whittier on Aug. 13 was presented.
- Active tasks that the coordinator is undertaking were presented. The next outreach event will be
  the LSGR virtual workshop with identified stakeholders held on October 26. The next stakeholder
  education event will take place early 2022.

Member Galia asked whether the WASC will be able to view the presentation for the outreach event on October 26 and requested for the PowerPoint presentation for LSGR Virtual Workshop prior to next WASC meeting on October 12th. Member Galia also asked that city staff be invited to the kickoff. Watershed Coordinator Anderson will provide list of stakeholders and presentation prior to the next WASC meeting so that committee has time to review and discuss collectively during the meeting. Grace Kast (OhanaVets) clarified that the kickoff meeting will be initial outreach and updating stakeholders on what is happening with LSGR WASC. And the kickoff meeting will not just be a presentation, there will also be interactive components.

#### 7. Presentation and Discussion Items:

## a) Scientific Studies Program - Microplastics in LA County Stormwater

Dr. Andrew Gray (UC Riverside) gave a presentation (see resources on WASC website) on the Microplastics in LA County Stormwater study submitted to the Scientific Studies Program.

Vice-Chair Rapp asked how the study will target a particular TMDL. Dr. Gray noted that the study doesn't address TMDLs since microplastics are not regulated in surface water but there are California State Water Resources Control Board concerns for drinking water.

Member Gonzalez asked how microplastics were impacting groundwater. Dr. Gray noted that groundwater hasn't been examined but he expects that groundwater is less impacted since microplastics are particulate matter.

## b) Scientific Studies Program - Regional Pathogen Reduction Study

Richard Watson provided a presentation with updates regarding the Study (see resources on WASC website).

Member Galia asked what the differences were between the upcoming Study application and the previously submitted one. Watson noted that the major changes were responses to the peer review: the upcoming study finalized a scope of work and specified types and locations of proposed sampling activities. Watson also clarified that community and stakeholder engagement activities have always been part of the project's application.

## c) Scientific Studies Program – Community Garden Stormwater Capture Investigation

Diana Campos Jimenez and Juan Diaz-Carreras from Los Angeles Community Garden Council provided a presentation about the Community Garden Stormwater Capture Investigation Study (see resources on WASC website). Benefits of the project not listed in the presentation are to help address TMDL compliance and engage community gardeners.

Member Knapp commented it was a great educational opportunity. Asked for clarification about whether the submitted project will include an implemented project. Diaz-Carreras clarified that implementation is not included, but the study will involve developing concept reports to further develop the project. The project can apply for funding as a grassroots effort. Diaz-Carreras emphasized the importance of community involvement for project implementation.

Vice-Chair Rapp asked if the concept reports would be feasibility studies to apply for funding. Diaz-Carreras said they will be desktop analyses that aren't sufficient for feasibility study but can be used for a technical resources application.

Vice-Chair Rapp asked whether the project team has considered non-municipal land ownership of properties for community gardens and notes that utility agencies have very strict requirements with land leases. Vice-Chair Rapp recommended that the study involves outreach to utilities who have impact on location of community gardens and negotiate opportunities for them to support community gardens for the study. Diaz-Carreras noted that the project includes a screening process for underlying landowners who are on board to modify land for garden. Vice-Chair recommended reaching out to utility agencies prior to project.



Member Galia asked whether all watersheds would need to commit to provide necessary funding. Diaz-Carreras said no, each watershed is independent and would affect the scope of the project.

Member Galia asked where there have been successes for these types of projects. Diaz-Carreras said they have seen success across the County (municipalities and private owners). Campos Jimenez provided clarification that they have not worked with schools because there is another organization for that. Member Knapp noted his previous experience with the LA Community Garden Council saw success throughout the County.
