



Safe Clean Water Program Announces Call For Stormwater Project Funding Applications For FY23-24

> FOR IMMEDIATE RELEASE December 16th, 2021

LOS ANGELES COUNTY PUBLIC WORKS

L.A. County, CA - Los Angeles County's Safe Clean Water Program is announcing its fourth annual call for stormwater project funding applications.

The Safe Clean Water Program, also known as Measure W, was passed by voters in 2018. It provides local, dedicated funding to modernize LA. County's 100-year-old stormwater system. In a region that imports two-chirds of its water and is impacted by increasingly severe droughts, this Program aims to increase the region's water supply and improve water quality while also enhancing communities and protecting public health.

The Program is funded by an annual local parcel tax which provides approximately \$280 million a year for stormwater and urban runoff capture projects. The Safe Clean Water Regional Program funds three different programs:

- The Infrastructure Program funds the design, construction, or operation and maintenance of stormwater projects that have a feasibility study already completed.
- The Technical Resources Program funds the development of a feasibility study for project concepts typically owned by parties that do not have the capacity to develop their own feasibility study.
- The Scientific Studies Program funds studies related to regional stormwater or urban runoff capture.



Goverance Committee evaluate and score projects, develop and recommend annual Stormatel Investment Plans and provide recommendations for funding. Eighte projects must improve water quality through regional stormwater or urban unoff capture. Competitive projects also horease valets reguly, utilize nature-based solutions, and provide community benefits such as creating green space and recreational goorhules, enhancing habitat, and increasing climate realisince.

To date, the Safe Clean Water Program has allocated \$240 million over two rounds of funding. It has funded 118 infrastructure projects and 45 technical resource projects covering 278,039 acres, as well as 17 scientific studies.

> Now, the Program is accepting applications for the Fiscal Year 23-24 funding round which ends on July 31, 2022.

Purpose


Experience to-date in the Regional Program reveals that aspects of Safe, Clican Water Program (SCWP) related to providing Disadvantaged Community Benefits require further guidance to better support achieving the outcomes sought. The SCWP emphasizes investments that produce benefits in or o directly to disadvantaged communities. Complying with the Disadvantaged Community Benefit policy in the Program is complex, and asserting with benefits accrue to which communities in ont easily quantified.

As of May 2021, the District Program is developing a study which, among many things, will review how other funding programs that direct investment in disadvantaged communities have worked to overcome the many challenges that remain when seeking to implement the SCWP policy. That study will inform future guidance, currently expected in the Spring of 2022, in support of Stormwater Investment Plan (SIP) development in the Regional Program for Year 4 (2022-23).

Program Definitions

"'Disadvantaged community' means a census block group that has an annual median household income of less than eighty percent (80%) of the Statewide annual median household income (as defined in Water Code section 79505.5)." (Section 16.03(H))



Example of a Census Block Group in the ULAR

"**Disadvantaged Community (DAC) Benefit**' means a Water Quality Benefit, Water Supply Benefit, and/or Community Investment Benefit located in a DAC or providing benefits directly to a DAC population." (*Section 16.03(I)*)

Provide Disadvantaged Community Benefits that are ≥110% of the ratio of the disadvantaged community population to the total population in the Watershed Area. (Section 18.04 (J))

Projects provide a Disadvantaged Community Benefit if:

1. Any of the construction effort is <u>within</u> a census block group designated as a disadvantaged community

OR

 None of the construction effort is within a census block group designated as a disadvantaged community BUT it provides a "<u>direct benefit</u>" to a census block group designated as a disadvantaged community.

What Counts as a "Direct Benefit?"

Whether a Project provides a "direct benefit" will be a decision made by WASCs on a project-by-project basis, considering:

- the goals of the SCWP,
- the benefits provided to the community by each Project, and
- the area within which those benefits will be felt.

How Can you as a WASC Validate Direct Benefits?

Hearing from community members is the best way to validate a direct benefit.










- City will identify an contact community groups and environmental organizations, Native American tribes believed to have inhabited the area, and public agencies that might have an interest in the project.

- Letters will be sent to five Native American tribes advising them of the project and asking for their input. A paleontologist to be on-call throughout the project.




