During Quarter 1 (June 3, 2021 - August 31, 2021), Council for Watershed Health's Watershed Coordinator, Clarasophia Gust, was on-boarded as one of the three Watershed Coordinators for the Upper Los Angeles River Watershed Area. On June 3, 2021 the contract was executed with Council for Watershed Health for Clarasophia Gust to serve as one of the three Watershed Coordinators for the Upper Los Angeles River Watershed Area (ULAR). A Notice to Proceed was issued on July 6th. In this first quarter of Watershed Coordination, progress was made toward tasks 1-9. The primary focus in this first quarter was on drafting and developing a Strategic Outreach and Engagement Plan (SOEP) in collaboration with the other two Upper Los Angeles River (ULAR) Watershed Coordinators, Carlos Moran and Adi Liberman (Attachment A-1). To inform the development of this SOEP, a survey was developed and administered to WASC members and key interested parties (Attachment A-2). One-on-one interviews were also held with ULAR WASC members to inform the SOEP activities.

The Watershed Coordinator began to identify and meet with interested parties across the ULAR Watershed Area. These included holding meetings with project proponents for current and potential future projects including Bowtie Demonstration Project, the LACCD stormwater capture projects, and Amigos de los Rios' projects. The Watershed Coordinator began identifying and engaging target audiences across stakeholders groups and identifying community priorities of groups such as the North Hills Neighborhood Council, Water Education for Latino Leaders, Montecito Heights community members, Friends of the LA River, and held discussions with Community Based Organization (CBO) partners to identify their climate and water resiliency needs. The Watershed Coordinator gave a presentation to the North Hills Neighborhood Council about the Safe, Clean Water Program in collaboration with Carlos Moran. A total of 42 meetings were held or attended in this first quarter. Effort was also focused on developing maps of the ULAR Watershed Area, databases, tracking systems, and interested parties/network lists of contacts across the watershed area. The Watershed Coordinator worked on developing a project intake form to be used to consistently track project opportunities and concepts across the ULAR.

The Watershed Coordinator began developing materials for outreach and education efforts and planning for outreach and education events. Additionally, the Watershed Coordinator tracked and participated in parallel regional efforts including key committee meetings such as IRWN SC, water quality policy research webinars and regional watershed coordinator meetings in June, July, and August. Participated in working on a collective strategy for integrating green schoolyard projects with school districts into the SCWP. Effort was also placed on coordination meetings with the ULAR watershed coordination team, including Environmental Outreach Strategies. Further, the Watershed Coordinator held and attended meetings with other Watershed Coordinators including Richard Watson (Rio Hondo), Tara Dales (Lower Los Angeles River), Nancy Schrodes (South Santa Monica Bay) and Mikaela Randolph and Michelle Struthers (Central Santa Monica Bay) to discuss coordination and collaboration across watershed area boundaries.

During Quarter 2 (September 1, 2021 - November 31, 2021), the Watershed Coordinator Clarasophia Gust made progress toward Task 1-9. The Strategic Outreach and Engagement Plan (SOEP) was presented to and approved by the Upper Los Angeles River (ULAR) Watershed Area Steering Committee (WASC) (Attachment A-1). The SOEP will guide and inform the work of the Watershed Coordinator over the course of this first year of Watershed Coordination.

In this quarter, a focus for the Watershed Coordinator was continuing to identify and engage target audiences across stakeholders groups and identifying community priorities of such groups. A total of 60 meetings were held or attended in this second quarter. The Watershed Coordinator had discussions with FOLAR, Montecito Heights community members, LA Sufi Center, Tataviam Land Conservancy, Our Water LA, Santa Susana Mountain Park Association, Amigos de los Rios, Dodgers Foundation, LAANE, API Forward Movement, East Yards, Pacoima Beautiful, Promesa Boyle Heights, Active SGV, and Community Repower Movement, among others (see Section B). The Watershed Coordinator prepared and delivered presentations about the Safe, Clean Water Program (SCWP) to the Burbank Eco-Council and the Glendale Environmental Coalition, both of whom expressed interest in engaging in Safe, Clean Water Program projects. Webinars relevant to water planning and climate resilience solutions were attended in this quarter. The Watershed Coordinator attended a tour of potential project sites identified by the Montecito Heights Neighborhood Improvement Association and created followup materials. The Watershed Coordinator created educational tabling materials and signage (Attachment A-2). These materials were used at two tabling events: the Heal the Bay Coastal Cleanup Day at Lewis MacAdams State Park which engaged attendees of the clean up day and patrons of the park, and a City Plants tree planting event in the Arts District which engaged event attendees and Arts District and Little Tokyo residents. Takeaways and input from these events were shared with the ULAR WASC during regular report outs. A presentation was also given to Occidental College students to raise awareness about the SCWP and water-related career paths.

Effort was placed on developing databases, tracking systems, and stakeholder/network lists for project proponents and contacts. During this quarter maps were prepared for the ULAR Watershed Area. The Watershed Coordinator also worked on developing a geographic point of contact map for the ULAR Watershed Coordinators (Attachment A-3) and

developed a project intake form (Attachment A-4) to be used to consistently track project opportunities and concepts across the ULAR. The ULAR Watershed Coordinators also initiated and will be regularly meeting with the City of LA Safe Clean Water Program Working Group and the LA County Public Works Stormwater Planning Team focused on developing ULAR projects in unincorporated areas. Outreach and education efforts included developing educational materials and signage. The WC developed a social media strategy and content to expand bilingual (English and Spanish) social media presence and outreach efforts by creating a CWH ULAR WC website, Facebook group, newsletter and Twitter (links to all are included in a flyer as part of Attachment A-5).

Throughout all this work, the Watershed Coordinator worked in close collaboration with the other CWH Watershed Coordinator, Carlos Moran, as part of the CWH Watershed Coordination Team, and coordinated efforts with the third ULAR Watershed Coordinator with Environmental Outreach Strategies, Adi Liberman. Additionally, the Watershed Coordinator tracked and participated in parallel regional efforts including key committee meetings such as IRWN SC, GreenLA Water Committee, LA River Urban Waters Federal Partnership, CASQA, and regional watershed coordinator meetings in July, August, and September. The Watershed Coordinator coordinated a working group of watershed coordinators to regularly meet and discuss a collective strategy for integrating green schoolyard projects with school districts into the SCWP. Further, the Watershed Coordinator held and attended focused meetings with other Watershed Coordinators including Richard Watson (Rio Hondo), Tara Dales (Lower Los Angeles River), Nancy Schrodes (South Santa Monica Bay) and Mikaela Randolph and Michelle Struthers (Central Santa Monica Bay) to discuss coordination and collaboration across watershed area boundaries.




