

Watershed Coordinator Activities

WC Activities since Last WASC Meeting (3-15-2022)

- Convened a virtual municipal-focused educational event on 3/21 through the SGVCOG
- Convened a virtual community-focused outreach event (with USGR Watershed Coordinator team)on 3/22
- Started planning for the next two outreach events 4/22 in Monrovia (at the City's Earth Day event) and 5/1 in Alhambra (at the City's ECO Fair)
- Started planning for next municipal-focused educational event with SGVCOG staff

Planned Upcoming Activity Focus

- Planning and convening outreach events on April 22 (in Monrovia) and May 1 (in Alhambra) in conjunction with community events happening in those cities.
- Convening a second educational event with a focus on municipal stakeholders – especially City Managers - through SGVCOG (likely to May or early June)
- Updating SOEP, including developing a new section on original inhabitants of area
- Consult with TreePeople DACIP project manager and Council for Watershed Health project manager re: needs assessment.

FYI – Virtual Funding Fair


- California Financing Coordinating Committee (CFCC) hosting a free virtual funding fair on May 17 and May 25.

Call to Action for Project Proponents


- July 31 deadline is coming quickly!
