#### A. Summary of Activities

Provide a high-level summary of activities completed this quarter and progress made toward completion of the annual scope of work.

This quarter, work focused on deeper community outreach and engagement through door-to-door outreach strategies, with an emphasis on reaching community members in disadvantaged or under-resourced communities. We also continued to strategize for our next watershed-wide event, aimed to be an in-person watershed tour highlighting Safe, Clean Water- aligned projects, which will be a major focus in the coming quarter.

In July, a draft of the Central Santa Monica Bay's (CSMB ) Strategic Outreach and Engagement Plan (SOEP) was approved by the CSMB Watershed Area Steering Committee (WASC). The Watershed Coordinators were pleased by the WASC members' engagement with the plan, and Mikaela spent much of July working with Michelle Struthers to incorporate WASC member s' feedback to finalize the plan. In the realm of project identification, Mikaela also focused on building relationships with neighborhood councils, giving Safe, Clean Water Program (SCWP) presentations at two council meetings (*Venice Neighborhood Council* and *Hollywood United Neighborhood Council*) to explore potential project ideas, increase awareness about the SCWP, and align community interests and priorities. In terms of community outreach, Mikaela worked with LA-based nonprofit CicLAvia, to table alongside our partners Jesse De La Cruz and Nicole Steele at CicLAvia South L.A., an open streets community event in July that promotes walking and biking. L.A. The team also participated in a tour of the TreePeople campus, located in the CSMB WA which highlighted a variety of stormwater management practices and included a discussion of potential solutions to stormwater-related issues. This team tour served as scoping and information gathering for development of a larger concept for a community tour to highlight projects that are in alignment with SCWP goals.

In August, Mikaela finalized her SOEP edits, after the plan was approved in July. She continued to outreach and prioritize building relationships with neighborhood councils, including presentations and engagement with the *Palms Neighborhood Council* and the *Empowerment Congress West Area Neighborhood Council*, and is working to get on additional neighborhood council meeting agendas. She also continued to explore project concepts and met with Technical Assistance Teams as needed, including monthly progress meeting with the Syd Kronenthal team. Jesse De La Cruz executed door-to-door engagement in South L.A. Jesse and Mikaela partnered with the South Central Neighborhood Council and Soledad Enrichment Action for *National Night Out* in South L.A., while Nicole tabled at four community events in the CSMB watershed area. At all of these events, the team offered SCWP information, raised awareness about the program, and encouraged attendees to participate in the SCWP community survey. Lastly, Mikaela participated in *Heal the Bay's* monthly *Nothing but Sand* beach clean up and provided the Beach Safety Talk which included *SCW* program talking points.

In September, Mikaela and the team outreached to an additional 19 neighborhood councils with the aim of presenting at their general meeting or at a committee meeting. Mikaela presented at the Del Rey Neighborhood Council meeting. She also attended the Culver City's *State of the City* community meeting, to better understand community priorities and concerns. Mikaela also spoke at multiple cleanups (Dockweiler Beach and Baldwin Hills Scenic Overlook) as part of Coastal Cleanup Day, incorporating information about the SCWP into her talks. Supervisor Holly Mitchell and her team were in attendance at the Dockweiler Beach site and offered remarks about the Safe Clean Water program and the recently passed plastics legislation. Mikaela coordinated and prepared, Jesse, Nicole, and SSMB

Watershed Coordinator Nancy Shrodes presented together at the Watershed Coordinator meeting in September elevating the intentional community partnership to increase breadth and depth of outreach efforts. They discussed community engagement strategies, including developing deep community ties and social impact metrics, and how their work is enriched by their partnership. Nicole also tabled at a community housing event in Inglewood, offering information about the SCWP to residents.

Collaboration with SGA Watershed Coordinator Michelle Struthers (CSMB) and other WCs has continued as we have shared resources and brainstormed tactics to accomplish the strategies outlined in the SOEP. Mikaela continues to coordinate on a frequent basis (multiple times a week) with fellow Heal the Bay South Santa Monica Bay (SSMB) Watershed Coordinator Nancy Shrodes.
