#### A. Summary of Activities

Following is a summary of activities completed during the second quarter of Year 2, and progress made toward completion of the annual scope of work. TreePeople is honored and grateful to serve as Coordinator for the Santa Clara River Watershed Area.

# 1. <u>Strategies used to integrate priorities for the community, municipalities, the watershed area, and the region</u>

TreePeople moved further on project development for unincorporated areas in the watershed, drawing on resources provided by the WaterTalks Program (IRWM Disadvantaged Community Involvement Program). This is a continuation of a key strategy used throughout Year One. These projects include:

- 1) Rural Water Supply Reliability
- 2) Septic System Evaluation Support Program
- 3) Acton Flooding Multi-benefit Solution
- 4) Native American Land Restoration with the Tataviam Land Conservancy
- 5) Tap Water Quality Testing Program
- 6) Small Water System Partnership

Funding has been awarded for the first project, and a draft work plan has been submitted to Dept. of Water Resources for review. The remaining projects are under development, which is expected to carry into 2023. The outcome is expected to be preparing projects for funding applications.

In addition, we have been working with the Watershed Wide Arundo Management group, which includes members of the WASC. A full proposal was submitted by TreePeople to the Strategic Growth Council to provide coordination across the watershed, build capacity of small CBOs and engage local, under-resourced communities and Tribes in the program. Should this effort be successful, it would provide the Watershed Wide Arundo Management group with multi-year coordination to help define a Watershed-wide management structure and launch campaigns to secure major funding for implementation.

#### 2. Partnerships and networks engaged

Much of our focus continued to be on meetings related to project development, including the Acton and Agua Dulce Town Councils and the Watershed-Wide Arundo Management Group (WWAM). With the latter, we met in depth with potential partners for the Strategic Growth Council Regional Climate Collaborative grant, including the Santa Clara River Conservancy, Friends of the Santa Clara River, the Nature Conservancy, Fernandeno Tataviam, Ventura County Resource Conservation District, CalTrout and UC Santa Barbara Institute of Marine Biology. Several of these organizations joined TreePeople to form a brand new environmental coalition in the region, including the California Native Plant Society, Citizens Climate Lobby, Sierra Club, Santa Clarita Hiking Club, and Santa Clarita Organization for Planning and the Environment, among others. We led group leaders from these organizations on a tour of TreePeople's restoration site in the upper watershed at San Francisquito Canyon and also hosted the monthly coalition meeting in October.

Another major network continues to be the collective of Watershed Coordinators across the SCWP. We attended monthly Coordinator meetings throughout the quarter and supported other Coordinator's efforts. Of special note was our collaboration with Watershed Coordinators on best practices for hosting stormwater project site tours. A site tour is planned for Quarter 3 in collaboration with Heal the Bay, Watershed Coordinators.

#### 3. Engagement of conventional and unconventional stakeholders

We continued surveying the region to determine topics of interest from which we can shape education events. TreePeople's engagement also included a presence at the Santa Clara River Rally, with an estimated audience of 1,200 people.

TreePeople supported the WASC by arranging two site tours for members, hosted by LA County Public Works. These tours were of two project sites that have been funded by SCWP in the SCR watershed area and have generated repeated questions from members.

Finally, updates on our activities were provided to the WASC as well as Town Council leaders throughout the period. We began and will continue engagement with the Val Verde Civic Association as well.

We also established an ongoing monthly presence at the Canyon Country and Newhall Farmers markets, where the market manager promotes our work and residents continue to request our presence.

TreePeople engaged a dedicated Community Organizer for the watershed area in Quarter 1, who canvassed state-defined Disadvantaged Communities in general outreach, and is now participating in monthly Farmers Markets in Canyon Country and Newhall.
