

QUARTERLY REPORT

A. Summary of Activities

This quarter, S. Groner Associates Inc. (SGA) completed the following in accordance with our Strategic Outreach and Engagement Plan goals:

UNDERSTAND COMMUNITY NEEDS

SGA continued collecting responses to our Community Needs Assessment Survey, which is available in English and Spanish. To date, we have collected 420 survey responses collected across LA County in conjunction with partners (SSMB, CSMB and LSGR Watershed Coordinators). See Attachment D for a summary of community survey responses collected to date. We also used the community survey results to create tailored reports for each municipality and shared them with project leads and municipal contacts. Finally, we attended 3 relevant events in the watershed to learn more about community needs and priorities (see Section B).

SOLICIT NEW PROJECTS

SGA held 10 meetings with interested parties to learn about their projects, their potential intersection with SCWP goals, and identify or discuss potential SCWP projects (see <u>Section B</u>). We also collaborated with the NSMB and SSMB Watershed Coordinators to create a presentation on SCWP to the Santa Monica Bay Restoration Commission.

SUPPORT CURRENT PROJECT APPLICANTS

SGA has continued to maintain our Funding and Cost Share database (Attachment C). We also developed a comprehensive resource guide, the "CSMB Applicant Resource Guide", with resources and considerations for parties planning to apply for SCW funding. On Sep. 21, we met with the Stantec Regional Coordination team to discuss strategies for identifying and sharing funding opportunities with SCWP project teams. On Sep. 22, we sent a newsletter to contacts in the watershed to share SCW updates and resources to aid project applicants (view newsletter here). Additionally, we attended the Urban Waters Federal Partnership Quarterly Meeting to gather information on new funding opportunities and attended a meeting with the Regional Coordination Team to learn about their findings regarding leveraged funding opportunities. We also created a slide deck on the synergies between Measure W and Measure A funding goals in preparation for a presentation to the Measure A committee. Finally, we identified and shared potential funding opportunities with the Fern Dell Restoration, Edward Vincent Jr. Park, and Ladera Heights project teams.

INCREASE GENERAL AWARENESS

SGA tabled at National Night Out in West Hollywood on Aug. 2, the "Ebb & Flow" event in Culver City on Sep. 11, and the "Run, Walk, and Roll" event in Griffith Park on Sep. 18 (see <u>Attachment E</u> for event photos). We spoke with the public about Safe Clean Water, collected survey responses, and distributed educational SCW materials. See <u>Attachment A</u> and <u>Attachment B</u> to view our event outreach materials.

WATERSHED COORDINATOR COLLABORATION

SGA has been attending monthly meetings of Watershed Coordinators, including facilitating the August meeting. In July, we attended a Watershed Coordinator working group focused on engaging schools in the SCWP. We continue to meet regularly with Heal the Bay to coordinate all outreach and engagement



activities. We also met with Stephany from the Council for Watershed Health to share our knowledge about the status of WHAM-identified stormwater projects.

SUPPORT THE WASC THROUGH INFORMATION SHARING

SGA attended monthly WASC meetings and created a calendar of presentation topics we plan to present to the WASC during the year. At the July meeting, we presented our Strategic Outreach and Engagement plan. At the September meeting, we presented summaries of the FY 22-23 project applications. Finally, we reviewed and summarized the 2022 LA County Parks Needs Assessment and plan to present highlights to the WASC in October.

We also corresponded with the Measure A Committee and created a slide deck on the synergies between Measure W and Measure A funding goals in preparation for a presentation to the Measure A committee.

D. Leveraged / Outside Funding Pursued

We have not pursued outside funding opportunities during this reporting period. Instead we researched and shared some cost-share ideas with the Fern Dell Restoration, Edward Vincent Jr. Park, and Ladera Heights project teams, and continued to build our Cost Share Database (<u>Attachment C</u>).

H. Expected activities next quarter

In the upcoming quarter, we anticipate accomplishing the following activities:

Focus Area 1: Understand Community Needs in the Watershed

- Continue meeting with interested parties to learn about community needs, with a focus on neighborhood councils and associations in Disadvantaged Communities
- Continue collecting responses to our Community Needs Survey at events and through online outreach

Focus Area 2: Solicit New Projects

- Present information about the Safe Clean Water program to potential applicants
- Conduct outreach to schools and college campuses to identify potential SCWP projects
- Engage the business community and city agencies on public-private partnership opportunities
- Support meaningful community engagement among project applicants by providing feedback and input



Focus Area 3: Support Funded SCWP Projects

- Send out a newsletter with helpful SCW resources to our contacts
- Continue to develop our cost-share database
- Conduct outreach to potential cost-share partners to identify opportunities for collaboration
- Identify and share cost-sharing opportunities with current SCWP projects
- Continue efforts to collect data on anticipated future funding needs of funded infrastructure projects
- Continue meeting with and offering feedback and recommendations to potential project applicants as to how their project concepts can best encompass community priorities and meet the goals of the SCWP program

Focus Area 4: Raise Public Awareness About SCWP

Raise awareness of SCWP at community events

Focus Area 5: Support the WASC Through Information Sharing

- Give updates at monthly WASC meetings, including information on: Disadvantaged Communities benefits of current project applications; Interim guidance on disadvantaged communities; and a review of Scientific Studies funded in other watersheds.
- Create a matrix for easy comparison of all current project applications.
- Complete monthly progress reporting






